Election Regulations

NOMINATION

NOMINATION PERIOD

7-14 October
2022

CANDIDATES SHOULD BE NOMINATED BY TWO SECONDRS (WITH THE NOMINATION FORM)

A) ALL FULL-TIME STUDENTS ARE ELIGIBLE TO BE CANDIDATES FOR ONE POSITION ON THE STUDENTS' UNION COMMITTEE OR TO BE ONE OF THE SECONDRS OF A CANDIDATE FOR ONE OF THE POSITIONS.

B) A CANDIDATE CANNOT BE HIS/HER OWN SECONDER FOR NOMINATION. ALSO, A CANDIDATE FOR A STUDENTS' UNION COMMITTEE POSITION CANNOT BE A SECONDER FOR OTHER CANDIDATES SEEKING POSITIONS.

C) CANDIDATES CANNOT VOTE DURING THE ELECTION VOTING PERIOD.

COUNTING PROCESS

ELECTION & BY-ELECTION

ELECTION PERIOD

20-27 October
2022

A) EVERY CANDIDATE MUST FIRST BE NOMINATED BY TWO SECONDRS BEFORE HE/SHE IS ELIGIBLE TO BECOME A CANDIDATE FOR A SINGLE POSITION ON THE COMMITTEE OF THE STUDENTS' UNION.

B) IF THERE IS MORE THAN ONE CANDIDATE FOR A POSITION, AN ONLINE ELECTION WILL BE HELD TO FACILITATE ALL STUDENTS TO VOTE. TO THIS END, CANDIDATES ARE RECOMMENDED TO SUBMIT A SELF-INTRODUCTION, INCLUDING SERVICE PLEDGES, OF AROUND 100-150 WORDS TO THE STUDENT AFFAIRS OFFICE.

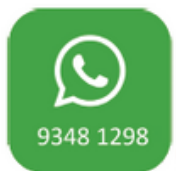
C) ALL STUDENTS, EXCEPT CANDIDATES, CAN VOTE ONCE FOR EACH POSITION ON THE ONLINE VOTING PLATFORM. THE CANDIDATE ATTRACTING THE HIGHEST NUMBER OF VOTES WILL BE ELECTED TO THAT POSITION IN THE COMMITTEE OF THE STUDENTS' UNION.

BY-ELECTION PERIOD

1-2 November
2022

D) IF THERE IS ONLY ONE CANDIDATE FOR A POSITION AFTER THE NOMINATION PERIOD, HE/SHE WILL BE AUTOMATICALLY ELECTED, AND NO ONLINE ELECTION WILL BE HELD.

E) IN THE EVENT OF THE ELECTION RESULTING IN A TIE, THE SECOND ROUND OF VOTING SHALL BE HELD BETWEEN THE CANDIDATES WHO HAVE TIED. ALL FULL-TIME STUDENTS (INCLUDING THE CANDIDATES WHO FAILED TO BE ELECTED IN THE ONLINE ELECTION) CAN PARTICIPATE IN THE BY-ELECTION FOR VACANT POSITIONS. AN ELECTED NOMINEE'S BALLOT PAPER CANNOT BE REUSED FOLLOWING THE ELECTION, BUT AN UNSUCCESSFUL NOMINEE'S BALLOT PAPER CAN BE REUSED FOR THE BY-ELECTION. THUS, ALL BY-ELECTION CONDITIONS REMAIN UNCHANGED.
